RELEASE AND WAIVER OF LIABILITY, ASSUMPTION OF RISK, AND INDEMNITY PARENTAL CONSENT AGREEMENT

In consideration of being allowed to participate in any way in the Tony Glavin Soccer Complex, LLC. programs, leagues, tournaments and related activities, for myself or personal representatives, assigns, heirs, and next of kin:

- A. Acknowledge, agree, and represent that I understand the nature of soccer activities and that I am qualified, in good health, and in proper physical condition to participate in such activity. I further agree and warrant that if at any time I believe conditions to be unsafe, I will immediately discontinue further participation in the activity.
- B. Acknowledge and fully understands that each participant will be engaging in activities that involve risk of serious injury, including permanent disability and death and severe social and economic losses which might result from their own actions, inaction or negligence of others, the rules of play, or the condition of the premises or any equipment used. Further, that there may be other risks not know to Tony Glavin Soccer Complex, LLC, Tony Glavin, INC
- C. Assumes all the foregoing risks and accepts personal responsibility for damages which may hereinafter occur following such injury, permanent disability or death.
- D. Releases, waives, discharges and covenants not to sue Tony Glavin Soccer Complex, Tony Glavin, INC, their affiliated clubs, their respective administrators, directors, agents, coaches and other employees of the organization, other participants, sponsoring agencies, sponsors, advertisers, and if applicable, owners and leaser of the premises used to conduct and event, all of which are hereafter referred to as "RELEASEES" from demands, losses or damages on account of injury from future participations, including death or damage to property, caused or alleged to be caused in who or whole or in part by the negligence of the "RELEASEES" or otherwise.
- E. RELEASES THE "RELEASEES" AND EXPRESSLY ASSUMES THE RISK OF INJURY AND DAMAGES; and will indemnify and hold harmless the "releases" as to any claims for injury and damage.
